gas.

: Hydrogen chloride. Sodium oxides. Nitrogen oxides.

5.3. Advice for firefighters

Precautionary measures fire : Exercise caution when fighting any chemical fire. Firefighting instructions : Use water spray or fog for cooling exposed containers.
